In network and out of network DDS both have the same Benefit Percentages, the only difference is that Out of network DDS can balance bill the difference to the patients.

Coesorce utilizes either the Aetna or Dentamax fee schedule - depending on the employer contract

**Step 4:** Inform patient of their benefit percentages and add any new network information to the Network Participation Chart

**REVIEW EOBs:** Helpful hints when EOB is not paid in the manner indicated on the Network Participation Chart or an insurance network does not recognize the direct contract the Practice has with a specific insurance group.

Cross Reference the EOB's , especially in the next 60 days, to ensure the claim are being paid under the correct PPO group.

In the event a claim was paid under the wrong network or does not recognize a direct contract the Practice has, the Practice must contact the Network the claim was submitted to and notify them that you were told the claim should have been paid by {{ Network name}} and have them assist you in troubleshooting. Most of the time, you will be informed their records do not show the Practice in direct or rented network with {{Network name}}. They will advise you to reach out to {{ Network name}} and instruct them to notify the network in which the claim was not paid under the correct fee schedule the Practice participation. On average, this will take 15 to 30 days to correct. Once corrected you can have the claims reprocessed under the correct fee.

Steps to Follow utilizing the following example:

Situation: An Ameriprise claim was paid under the Connection fee. The Network Participation Chart indicated it should have been paid under Principal. When you reach out to Ameriprise to troubleshoot, you find out they do not see the Practice in direct contract with Principal but they see the Practice in the Connection rented network. In order to resolve the issue you need to complete the following steps:

**Step 1:** Ask Ameriprise to issue a Case Id # so you can official record the issue with Ameriprise and provide you means to reference the issue with another provider relations person in future calls- at least until the issue has been resolved . You will need to write and save the number in a place for you to reference in future calls .

**Step 2:** Reach out to Principal , notify them of the situation, and ask that they reach out to Ameriprise to inform them the Practice is in direct contract with Principal.

Ask Principal for a Case Id # so you can official record the issue with Principal and provide you means to reference the issue with another provider relations person in future call

**Step 3:** Call Ameriprise 15 to 30 days to later to see if the issue has been resolved or if it will take more time for them to update their records

**Step 4:** Resubmit the claims that were paid incorrectly to have them reprocessed.
